FEBRUARY 18, 2015 - OB

Recommendation: That the Oversight Board of the Successor Agency to the Walnut Improvement Agency adopt Resolution OB 15-03, "A Resolution of the Oversight Board of the Successor Agency to the Walnut Improvement Agency confirming repayment of a specific advance."

ASD/Ogawa presented a staff report. She reported that the Agency issued a check in the amount of \$442,129.09 to the City for reimbursement of the advancement, which was deposited in the City's account on July 6, 2012. During the State Controller's Walnut improvement Agency, Asset Transfer Review, for the period of January 1, 2011 through January 31, 2012 issued on September 29, 2014, the State Controller's office declared the reimbursement of the advancement "unallowable" and demanded its return to the Successor Agency to the Walnut Improvement Agency, formerly the Redevelopment Agency. The City and the Walnut Improvement Agency had entered into a reimbursement agreement pursuant to Resolution No. 2130.

CA/Montgomery needs the approval from the Oversight Board by adopting Resolution OB 15-03 confirming repayment of a specific advance.
